Membership: TBSSB membership dues for you and for all members in your group as listed above are included in the trip price.
Transferring: Any participant as listed above transferring from one trip to another shall be considered as having cancelled the first trip and is subject to a \$25 transfer fee (reduced cancellation fee) for administrative costs. All transfers must be in writing AND submitted prior to the cancellation date as advertised in the official Club trip description for this trip.
Roommates: It is the responsibility of all participants to assure "compatibility" prior to signing up. Trip Leader will assist, but is not responsible for finding roommates. Space is held for singles only if participant is willing to pay single rate if a roommate is not found.
Insurance: TBSSB recommends travel insurance for all trips. See www.insuremytrip.com for more info or do a search on the Web.
Seats and Bedding: TBSSB will make every effort to accommodate requests for airline seating and condominium/hotel/lodge bedding configuration. However, we cannot guarantee any particular seats or bedding arrangements, since we have no control over this.
Barge/Hotel Only: Barge/Hotel-only participants will be responsible to arrange and bear the cost of ground transportation to & from the airport to the barge/hotel. Space on Club buses can be used **if available** (*your Trip Leader's decision*) if traveler arrives earlier than trip plane and is present when the bus departs.
Airlines: TBSSB is not responsible for airline schedule changes and/or change of airline.
Frequent Flyer: TBSSB will submit your frequent flyer number to the airline, but ultimately you are responsible to make sure the airline has it in their system.
Trip Prices: Participants are subject to all new fees or taxes imposed by either the government, airline, lodging, or any agency involved.

All airlines, ground transportation, & lodgings are Non-Smoking.

Release of Liability and Hold Harmless Agreement:

I, as the Primary participant, and those participants (GENERAL MEMBERSHIP) who are listed by me on page one who are members of my group, do hereby appoint TAMPA BAY SNOW SKIERS & BOARDERS ("Club"), its officers and agents, as my/our agent to perform all acts and to enter into any and all contracts as may be deemed as desirable in connection with any trip or other club activity. I/We understand that the Club acts only as a coordinator and accepts no responsibility for the services of any person, airline, motor coach, insurance company, barge/hotel, or organization whatsoever rendering any of the services or accommodations being offered on any trip. Bike and Barge trip and any other activity fees are based upon current tariffs and are subject to change without notice. The Club accepts no responsibility in whole or in part for any delay, delayed departure or arrival, missed plane or other carrier connections, loss, damage or injury to person or property, mechanical defect or any failure of any nature, howsoever caused, or for any substitution of barge/lodging or of common carrier, with or without notice, or for any additional expenses occasioned thereby. I/We fully understand that the Club is a voluntary association run by volunteers who are not professionally trained in conducting Bike and Barge trips or other activities. By participating, I/we do not rely on the expertise of any director, officer, activity coordinator, or the agents of any of the foregoing. I/We agree that I/we am/are solely responsible for my/our personal safety and conduct and I, as the Primary participant, am responsible for meeting all payment deadlines and obligations to Club, bank, and card issuers. Should I/we miss departure, I understand that I may not be able to recover any part of my/our trip or activity payment. I agree to indemnify and hold harmless the Club, its officers, and agents or contractors from any loss or cost for expense incurred by or attributable in any way with any Bike and Barge trip or other activity. I/We agree to abide by the Bylaws, rules, and regulations of the Club and the Trip Leader(s) in connection with any Bike and Barge trip or other activity.

Cancellation Policy:

1. Cancellation by any participant (as listed on this trip application) **prior to the cancellation date**, as specified/advertised in the TBSSB official trip description for this trip, will result in a \$50.00 cancellation fee (per person). When cancelling **after the cancellation date**, the traveler will be responsible for the total cost of the trip for each person cancelling. Cancellation after the cancellation date will also result in a minimum cancellation fee of **\$500 per person** for a non-domestic Bike and Barge trip. Some trips have more restrictive cancellation provisions due to airline or lodging restrictions. Any participant may obtain a substitute participant to take his/her place, but the "Primary" participant shall be liable for the cancellation fee cited above and any charges incurred due to name changes or any penalties incurred by the Club.
2. All cancellations by participants must be in writing by the "Primary" participant to the designated Club Trip Leader for this trip.
3. All trip payments are due on the date specified on the official trip description found on the Club's website. If not received when specified, the "Primary" participant risks losing his/her place(s) on the trip and being treated as having cancelled. (Contact your Trip Leader if you are in doubt as to when your trip payments are due.)
4. In the event a trip is cancelled by the Club due to any conditions such as a lack of participation, or for any reason beyond the control of the Club, Primary participant will receive a full refund of all paid monies.

NOTE: Prices on all trips may be subject to change due to unforeseen increases. The Club and its agents have no control or responsibility over such increases. The Primary participant will be responsible to pay for these increases should they occur.
